Routes to Full Registration with the GMC:

There are currently 4 routes to registration with the GMC for international medical graduates wishing to secure a paid post in the UK should consider the following routes:

Professional Linguistics and Assessment Board (PLAB) Examination	IMGs who have graduated from a medical school outside of the UK, European Economic Area (EEA) or Switzerland, and are not eligible for the other 3 routes will probably need to take the PLAB test. The PLAB test will check that IMGs know and can do the same as a doctor starting the second year of their Foundation Programme training in the UK. There are two parts to this examination. Part 1 is a written multiple- choice exam, with 180 single best answer questions. Part 2 is a practical objective structured clinical exam, known as an OSCE. IMGs will need to pass both examinations.
RCPath Sponsorship Scheme	IMGs may be eligible for sponsorship from the College. Sponsored doctors are normally doctors who are already some way advanced in their chosen specialty and who wish to pursue further specialty training in the UK. Sponsors recommend to the GMC that each doctor they sponsor possesses the knowledge, skills and experience necessary for practice as a fully registered medical practitioner in the UK
Postgraduate Qualification Route (PGQ Route)	The GMC accept certain postgraduate qualifications as evidence that a doctor applying for full registration with a license to practice who has the necessary knowledge, skills and experience. Acceptable Overseas Registration Examination Route	 International medical graduates who have passed an acceptable overseas registration exam. Doctors should contact the GMC directly regarding this route (img@gmc-uk.org). The following overseas examinations are accepted: United States Medical Licensing Exam: Step 1, Step 2 clinical knowledge and Step 2 clinical skills.; For Step 2 clinical skills, your pass must be on or before 13 March 2020. Medical Council of Canada Qualification Examination 2 (taken in English) on or before 27 October 2020 The Australian Medical Council Clinical Examination on or before 5 March 2020

The Royal College of Pathologists recommendations:

- The College recommend that all doctors who are concerned about keeping their primary medical qualification safe upload their credentials to <u>the Electronic Portfolio</u> <u>of International Credentials (ECFMG/EPIC)</u>. Doctors wishing to pursue medical practice in the UK will be required to verify their credentials for registration using this platform.
- 2. Ukrainian doctors arriving in the UK seeking asylum or refugee status are encouraged to register with the BMA. The BMA have a refugee scheme which provides assistance and support to all refugee/asylum doctors who will be obtaining their GMC registration via the PLAB route.
