The College

The College has a key role in the professional and strategic aspects of pathology services in the development and delivery of healthcare. Those holding office in the College provide professional leadership, and thereby contribute at a national level across all 4 UK nations and internationally to the maintenance and development of pathology services, and the quality of care that patients receive.

The College expects its office holders to be proactive, and to provide leadership not only in their own specialty, but also in pathology in general, in the wider context of health services. The College's influence extends to all sectors of healthcare provision.

The College is its membership, and the coordination between international, national, regional and local activities is paramount. All office holders are expected to subscribe to these principles, and the local leads and regional chairs are expected to provide the professional leadership within their region. The College is also expected to provide advice and guidance on specialty-specific issues nationally, regionally and locally. The Specialty Advisory Committees (SACs) provide professional leadership within their specialty.

Main purpose

The primary responsibility of this role is to make sure authors of pathology guidelines have responded to open consultation comments according to the agreed process and, where appropriate, have acted on feedback by amending the guideline.

Key duties

- Review consultation comments online using the College consultation tool: ensure consultation comments have been reviewed by authors and ensure all responses are satisfactory.
- **Collaborate with authors:** work closely with guideline authors via email or other online communication tools to ensure they have provided clear reasoning for accepting or rejecting feedback from stakeholders and consultees.
- **National and international standards:** Work with guideline authors to ensure that guidelines align with relevant national and international standards where appropriate

- Ensure appropriate amendments: confirm that authors have amended guidelines where appropriate based on the feedback received.
- **Communicate with the Professional Guidelines team:** notify the team once these actions are complete, so they can initiate the process of the revised guideline, including a final editorial review and publication.
- **Clinical sign-off:** provide clinical approval of the consultation report, which will be posted on the College's consultation response pages and each guideline document.

Scope and accountability

The Professional Guidelines and Publishing and Digital teams work collaboratively to deliver the guideline production programme. As this is a remote position, you will collaborate online with these teams, meeting the deadlines set within this programme.

The post holder holds a crucial role in delivering oversight to the post-consultation comment response process. The post holder will escalate issues to relevant experts as the need arises in consultation with the Professional Guidelines team.

The post holder is responsible for finalising and signing off the revised guidelines before notifying the appropriate team that the guideline is ready for a final editorial review.

The post holder should complete a review within 2 weeks. (It should take between 1 and 4 hours to review a consultation report.)

- 24 autopsy guidelines
