Professor Madrigal is UCL Pro-Vice-Provost for Latin-America and Scientific Director of Anthony Nolan and Professor of Haematology at the Royal Free Hospital and UCL Cancer

Institute. He is a Fellow of the Royal College of Pathologists, the Royal College of Physicans and The Academy of Medical Sciences. He was recently elected as an Academic Corresponding Member of the Spanish National Academy of Medicine, an Active Member of the European Academy of Science and Arts and as an Association Member of BUPA. He is an internationally respected, influential scientist in the field of stem cell transplantation, histocompatibility and immunogenetics, whose career began in Mexico. His seminal research work has been the platform on which many recent advances in bone marrow transplantation have depended. His research has impacted upon clinical practice, influenced the development of new tissue typing reagents by healthcare industries and has defined viral and tumour specific targets that are used worldwide in vaccination and cell therapy. His successful achievements as past-President of EBMT are recognised worldwide and he has received several awards and prizes.
