President's Message

It's heating up! Not just the weather, but across healthcare, politics and policy. In the last 6 months, we have had the abolition notice for NHSE, the 10-Year Health Plan for England, the Elective Care Plan, the Leng Review, the Life Sciences Sector Plan, and very soon we will have the Medical Training Review and later in the year the National Cancer Plan for England and Long-Term Workforce Plan 2.

It's a lot to take in... A lot of uncertainties, concerns, optimism and pessimism. What is clear, however, is that all these plans are important for pathology and pathology is important for these plans. So, lots of plans, lots of ideas, but little so far in the way of implementation, funding or even the creation of turning space to have a crack at things.

Workforce, as always, remains the biggest issue for our services. The emergence of valuable data and information from our College Workforce census is beginning to paint a very bleak picture for future pathology service delivery – delivery that is already failing in some of our disciplines, notably paediatric and perinatal pathology. College advocacy in this area remains strong, which is important – given there is no workforce planning model, we must instead ensure we are at the

table, with the evidence, to influence decisionmaking.

The 10-Year Health Plan for England aims to 'over the next 3 years, create 1,000 new specialty training posts with a focus on specialties where there is greatest need'. However, we learn there is no extra funding to support these posts from NHSE; instead, NHS Trusts will be asked to fund the posts – a mechanism that is already failing pathology, and one that has seen 20% of our existing histopathology training posts lost across the last 2 years. So, it is vital we seek clarity and appeal for other options.

Medical Training Review

This review, led by Professor Sir Stephen Powis and Professor Sir Chris Whitty, should be published in a few weeks' time. The review aims to 'modernise postgraduate medical education to better align with the evolving needs of patients, doctors and healthcare services', and is also likely to prioritise UK graduates and existing UK doctors for specialty training posts. We will look very closely at the detail when published, and you can read our evidence to the review.

The Leng Review

This <u>review</u>, led by Professor Gillian Leng, has just reported. It was commissioned to assess the safety and effectiveness of the physician associate (PA) and anaesthesia associate professions and their contributions to healthcare. The recommendations, accepted by Government, include a name change, new uniforms and badges, and more focus on scope of practice, supervision and regulation.

Royal colleges have been suggested as possible hosts for a new permanent faculty for professional leadership; we, along with other colleges, are considering the options carefully. For pathology, PAs will become more common, especially in our patient-facing services – we cannot ignore the part we need to play to make this work.

Meanwhile, while the review has been welcomed by all, not everyone is perfectly happy. Let's not forget that many of the serious concerns about PAs were driven by resident doctor groups, no doubt as part of their general unhappiness with pay, conditions and decreasing opportunities for them in their future careers. This all still needs to be resolved.

College Pathology Plan

The next 6 months are crucial for the future of pathology services across the UK. The multitude of plans emerging from Government clearly point out pathology as being a main player, vital for delivery of the changes needed across the UK to improve healthcare.

With limited new money, lack of workforce and the need for significant investment in technology, we need to be clever, strategic and focused. The developing Pathology Plan driven by the College will clearly outline what needs to be done, when and by whom. I'd encourage you to be a part of it, promote it, work with it.

College response to the NHS 10-Year Health Plan

We welcomed the plan, which comes at a time when NHS services face significant pressure, with many patients still experiencing delays in diagnosis and access to treatment. Our response is here, and we await detail about how the plan will be implemented. Its high-level nature means that much of the detail around pathology within the NHS is not clear.

However, there is a huge amount of pathology in the plan. Pathology will be central to delivering the 3 shifts it sets out – from the hospital to community, from analogue to digital, and from sickness to prevention. Pathology can enable the delivery of the 10-Year Health Plan, while also supporting wider aspects of healthcare provision, both now and in the future.

5th NHS Pathology Conference: Improving NHS Diagnostics

I was delighted to deliver a keynote address at the 5th NHS Pathology Conference on improving NHS Diagnostics, where I outlined what the main pathology challenges are at government, NHS, private sector, professional body, pathology provider and patient level, and gave some

pragmatic thoughts on possible solutions and contingencies.

I also joined a panel of national leaders to discuss 'Pathology across the UK – Meeting demand, building capacity'. The panel explored how the sector is evolving to meet increasing pressures – areas covered included workforce and resource challenges, to the opportunities offered by digital transformation, automation and AI.

Workforce Census 2025 – first spotlight launched

We have just launched the first in our series of census spotlights, which highlights key workforce concerns, including a potential retirement cliff edge, long hours and widespread anxiety over staffing levels. This was covered in the Pathologist.

Between February and March 2025, we contacted 9,539 members, registered trainees and candidates across the UK – thank you to everyone who took the time to respond to the census. We now have our richest dataset to date, which enables the College to highlight, with evidence, the growing challenges facing the pathology workforce and pathology services.

Serious Hazards of Transfusion

We were proud to endorse the new Serious Hazards of Transfusion (SHOT) Transfusion Safety Standards. Launched at the Annual SHOT Symposium 2025, the standards have been developed with clinicians, scientists, regulators and, crucially, patient representatives, whose voices have helped shape key elements of these standards. The aim of the standards is to embed a proactive approach to improve patient safety, enhance governance and accountability, and infuse transparency and learning across all levels of care.

Dementia adult screening programme consultation

The UK National Screening Committee (NSC) has opened a consultation on the latest evidence relating to population screening for dementia. The UK NSC is consulting on whether to change its recommendation on this condition and is accepting comments. We will submit a College response and are encouraging members to give their individual views.

Working for members

Public Accounts Committee report on antimicrobial resistance recognises the vital role of medical microbiology and virology

The Public Accounts Committee published its report: <u>Antimicrobial resistance</u>: <u>addressing the risks</u>. The report makes it clear that consultant medical microbiologists and virologists are essential to address antimicrobial resistance. The committee uses College evidence provided to the inquiry to highlight gaps in the workforce that are jeopardising efforts to optimise prescribing

and control infection. The College is pleased to see this report and its recommendations, including acknowledgement that investment in the workforce is much required.

Release of doctors for the purpose for carrying out work for the wider health system The 4 Chief Medical Officers, the GMC, the NHS National Medical Director and the Academy of Medical Royal Colleges have written to NHS Boards to encourage them to continue to look favourably on requests from doctors seeking their support to undertake national or regional work for the wider benefit of the public and of health services.

We welcome this letter as a strong expression of support for the work our member volunteers undertake for the College, which reinforces its value as a crucial investment in the functioning of the health systems across the UK. We encourage members to read it, circulate it to colleagues and refer to it in discussions with employers when seeking to pursue these roles. We are in the process of developing further guidance to help support our members who wish to be released for these purposes and will provide this advice shortly. Guidance on the appointment of consultant clinical scientists in microbiology and virology to employing bodies in the UK

New updated guidance has been published that supports the appointment of consultant clinical scientists to consultant posts in microbiology and virology across the UK. Developed collaboratively by the College, the Association for Laboratory Medicine and the British Infection Association, it reflects current workforce challenges and the increasing role of clinical scientists in consultant positions.

The guidance provides practical advice for employing bodies, covering all stages of the appointment process – from job description to interview – and includes microbiology- and virology-specific considerations. It is intended to support employers in appointing high-quality candidates to consultant posts. The full guidance is available on our website.

Medical Examiner training – Virtual

The College is the <u>lead medical royal college for medical examiners</u> and provides training for any doctor wishing to work as a medical examiner. Participants will need to complete mandatory 26 e-learning modules and attend an entire face-to-face virtual training day to receive a certificate of completion. The day includes short presentations, small group discussions of case scenarios and the opportunity to share experience. Medical examiner training is open only to medically gualified individuals who work in England and Wales.

New medical examiners who successfully complete the training and the e-learning modules will be invited to join the College as members.

Medical Examiner Officer (MEO) Virtual Training

Wednesday, 1 October 2025

CPD credits: 6

The College also leads on the training of medical examiner officers (MEOs).

MEOs work closely with medical examiners and undertake tasks such as coordinating the completion of death certificates and referrals to the coroner, and speaking to clinicians and bereaved families.

MEOs may come from a wide range of backgrounds. For example, nurses, healthcare scientists or bereavement officers although this list is not exhaustive. More information, including a model job description, is on the College website.

The face-to-face virtual training day is the second part of MEO training. Everyone attending the course must have completed the 26 mandatory core e-learning modules before the date of the course to get the most out of the training day. The e-learning modules <u>can be accessed</u> <u>here</u>. (Registration with e-Learning for Healthcare is required.)
