# President's Message

### New Government

It's fair to say that the new government have hit the ground running, with much enthusiasm and a refreshing and honest dialogue emerging with the medical profession and the public that we have not seen for many years. The challenges are clearly the same with waiting lists, estate backlogs, archaic IT systems and most importantly staff shortages.

We have already established a fruitful relationship with the Secretary of State for Health and Social Care, Wes Streeting, which we will build on. His remit covers the NHS and social care in England only, so it is vital that we continue ongoing dialogue with the existing devolved healthcare teams.

Once a fuller picture emerges, we will establish relationships with the wider health team and their shadows, and with health representatives from other parties. We will be writing to them to arrange meetings and offer laboratory visits.

There are over 300 successful candidates who have become MPs for the first time, and it's likely that few of this new intake of MPs will be aware how vital pathology is to prevention, diagnosis, and treatment. We'll work hard to raise the profile of pathologists and pathology – crucial when decisions are being made about workforce, investment and health policy priorities.

In the autumn, we will re-establish our <u>All-Party</u> <u>Parliamentary Group for Diagnostics.</u> We will also review the membership of Select Committees and other All-Party Parliamentary Groups to continue our programme of engagement.



We have already done work to promote our <u>key</u> <u>election priorities</u> to MPs, outlining some of the key challenges you face in delivering the best patient care.

### The Lord Darzi Independent Investigation into the Performance of the National Health Service in England Review

A short life review of the NHS in England has been commissioned by government and Lord Darzi will lead on this. It is due to report in September, so only a very light touch overview is expected. I am delighted that both I and RCPath immediate past president, Prof Mike Osborn, have been selected to join the Expert Reference Group (ERG) for the review. Clearly the review will be about collecting and presenting data about how the NHS is currently working (or not). It is vital we are able to highlight the challenges we face across pathology services and that significant investment in buildings, equipment, automation, IT and most importantly the training of pathologists and scientists is urgently required. You, as members of this College need to contribute and help formulate our response - your profession depends on it.

# Threats to pathology service continuity and the need for contingency planning.

Pathology services are vital for healthcare. Typically this is best exemplified when things go wrong that impact service delivery, and the true importance of pathology is revealed. Increasing threats from IT failures/security breaches, supply chain failure, regulatory induced withdrawal of products and sadly service collapse as a result of workforce shortages are becoming more frequent.

It is important that we anticipate and have ready to go contingencies in place to mitigate such impact and ensure that if we cannot do what is best for patients, then we do the best we can.

This is why our focus on workforce/workload strategy includes a pillar for contingency planning given the short to medium term capacity is unlikely to be there. Sadly as we have seen many Paediatric & Perinatal services collapse in recent months, despite mutual aid processes in place, the need for emergency protocols to salvage remnants of service as best we can are now being enacted, while at the same time ensuring we are open and transparent with parents and families. This is so important and will be an unwelcome but familiar part of our services for the foreseeable future and it is our responsibility to deliver on this while ensuring that visibility and longer term solutions are in place. *This College will stand up for pathology and for patients in this regard.* 

# The Covid Inquiry - Module 1 Report – The resilience and preparedness of the United Kingdom

This first report from the <u>Covid Inquiry</u> was published recently and was very damning regarding not just the lack of preparedness that existed across the UK leading up to the pandemic but the way in which Government in particular had ignored the clear warnings and recommendations from even their own audits and reviews. The next pandemic is described as *when* not *if*, and while much experience has been gathered from the Covid-19 era, it's clear that the readiness, capacity and resilience of the NHS may now be even less than before.

Diagnostic testing and infection prevention and control played a huge part and it is important that we continue to highlight the need for potent contingency planning that enables our services to both cope and scale up at pace when required.

### **RCPath Achievement Awards 2024**

It was a real privilege and pleasure to be able to present six pathology teams with an RCPath Achievement Award at the College's annual dinner in June.

### Learning lessons from coroners' reports – Preventable Deaths Tracker

One in five deaths are avoidable, yet there is no system in place to investigate these deaths. The Preventable Deaths Tracker is a vigilance platform that provides the first database of all published coroner reports in England and Wales. In this talk, Dr Richards will share insights about the development of the Tracker and the future research as the new 2024 King's Prize Fellow.

### From snails to sperm whales: PMs across 10 orders of magnitude

Dr Simon Spiro is the veterinary pathologist for the Zoological Society of London, where he is responsible for the diagnostic pathology of the society's 23,000 animals of 800 species. He is also the pathologist for the Cetacean Strandings Investigation Programme (CSIP) which investigates dead whales, dolphins, sharks, turtles, and seals in English and Welsh waters. In this talk he will cover the

what, where, how and why of wildlife pathology, covering everything from the practicalities of performing post mortem examinations on everything from tiny invertebrates up to massive whales, to the science and conservation work that results. This talk will cover topics such as cholesterol mediated diseases in meerkats, bacterial diseases in bats and orthopaedic disease in whales, all told with the aid of pictures, video and digital microscopy.

### Medical examiner training

The College is the <u>lead medical royal college for medical examiners</u> and provides training for any doctor wishing to work as a medical examiner. Participants will need to complete mandatory 26 e-learning modules and attend an entire face-to-face training day to receive a certificate of completion. The day includes short presentations, small group discussions of case scenarios and the opportunity to share experience. Medical Examiner Training is open only to medically qualified individuals who work in England and Wales.

New medical examiners who successfully complete the training and the e-learning modules will be invited to join the College as members.

### Medical examiner officer training

The College also leads on the training of medical examiner officers (MEOs).

MEOs work closely with medical examiners and undertake tasks such as coordinating the completion of death certificates and referrals to the coroner, and speaking to clinicians and bereaved families.

MEOs may come from a wide range of backgrounds. For example, nurses, healthcare scientists or bereavement officers although this list is not exhaustive. More information, including a <u>model job</u> <u>description, is on the College website.</u>

The face-to-face training day is the second part of MEO training. Everyone attending the course must have completed the 26 mandatory core e-learning modules before the date of the course to get the most out of the training day.
